#### **Ambassador Institute**

World Mission Board discussing the interaction between Orality Institute and Ambassador Institute in Uganda.

David Johnson shared of his conversations with Michael Rokenbrodt and his brother Greg Johnson (the Chair of International Orality Institute). The WMB conversation continued regarding the topic of Orality and AFLC interaction. There was concern that IOI marketing and publications were misleading and dishonest, claiming an intermingling of staff and activities with AFLC World Missions. The decision was made for David Johnson to contact his brother Greg and see about the IOI Board challenging Kevin to consider and revise his approach to marketing, the IOI website, and future newsletters. A clear and honest distinction needs to be made about the correct identity of IOI staff versus AFLC Missionaries and ministries. No conflict is desired, only correcting the honest distinctions between the two. David Johnson agreed to research the issue, and contact Greg for future steps.
